### **❖** ISJR Lifetime Achievement Award

Members of ISJR are asked to submit nominations for the first annual ISJR Lifetime Achievement Award. This award honors scholars for distinguished contributions to the scientific study of justice and efforts to advance justice as a field of study (mentorship, etc).

Please send a 1-2 page nomination letter with a copy of the nominee's curriculum vitae to the Secretary of ISJR (tom.tyler@nyu,.edu) (email nominations with pdf or MSWord attachments of the nomination and the nominee's CV are strongly encouraged). The recipient of the award will be decided by a vote of the ISJR executive committee. Current members of the ISJR executive committee are not eligible for this award. Deadline for nominations is November 15, 2007. The award winner will be announced by Junary 15, 2007 and the award winner will be invited to give a special address at the ISJR conference in Australia.

# ❖ ISJR Young Scholar Award

Members of ISJR are asked to nominate excellent young justice scholars for this award. Self-nominations are welcomed. The nomination should

include a detailed statement explaining the accomplishments of the scholar and should be accompanied by a CV, including a publication list and copies of the up to five of the nominees most important publications. Nominations and nomination materials by E-mail are preferred, but hard copies will also be accepted. The recipient of this award may not have held a PhD for more than 10 years (from the date nominations are due). The award winner will be announced by January 15, 2007 and the award winner will be invited to give a special address at the ISJR conference in Australia.

### 2006 Morton Deutsch Award

The Morton Deutsch award is given annually by ISJR for the best article published in Social Justice Research every year, with preference given to contributions from investigators who are relatively early in their research careers. The 2006 winner is Sarah F. Brosnan for her article entitled "Nonhuman Species' Reactions to Inequity and Their Implications for Fairness" (published in the June 2006 issue of SJR). The committee also decided to name an honorable mention, which goes to Michael Wenzel, who published two articles in SJR in 2006, including "A Letter from the Tax Office" (published in the September 2006 issue). Congratulations to both authors! They will be officially recognized at the ISJR conference in Australia. The committee this year was comprised of Carolyn Hafer, Keith Murnighan, and John Jost (chair).

### Grants to ISJR Members

Kees van den Bos (Utrecht University), along with Annemarie Loseman (Utrecht University) and Bertjan Doosje (University of Amsterdam), were recently awarded a grant (EUR 150,000) by the Research Centre of the Ministry of Justice and the National Coordinator for Counterterrorism to study the radicalization of Dutch youth. This research will focus on factors like relative deprivation and perceived injustice as moderators of these radicalization processes.
